In exercise of the powers conferred by section 18 of the Himachal Pradesh Private Educational Institutions (Regulatory Commission) Act, 2010 (Act No. 15 of 2011), the Governor, Himachal Pradesh is pleased to make the following Rules further to amend the Himachal Pradesh Private Educational Institutions (Regulatory Commission) Rules, 2011, published in the Rajptra, Himachal Pradesh dated 27<sup>th</sup> July, 2011 vide this department notification number EDN-A-Ka(3)-1/2011, subject to the final outcome of the Civil Appeal No. 11290/ 2013 pending adjudication before the Hon'ble Supreme Court, namely:-

Short title and commencement.

 1 (1) These Rules may be called the Himachal Pradesh Private Educational Institutions (Regulatory Commission) Amendment Rules, 2021.

(2) These Rules shall come into force from the date of publication in the Rajpatra (e-Gazette), Himachal Pradesh.

 In Rule 3 of the Himachal Pradesh Private Educational Institutions (Regulatory Commission) Rules, 2011, for sub Rules (3), (4), (5) and (6), the following shall be substituted, namely:-

"(3) The Chairperson and members shall be entitled to the residential accommodation at the headquarters of the Commission, if available in general pool, as per their entitlement under the Rules governing

allotment of such Government accommodation.

:2:

- (4) The Chairperson and members shall be entitled to House Rent Allowance (HRA) as per their entitlement under the rules/ instructions issued by the government from time to time relating to the grant of HRA. The telephone facilities will also be admissible as per their entitlement under the orders of the State Government issued from time to time relating to grant of such facilities.
- (5) The Chairperson and the members shall be entitled to such Travelling allowance and Daily Allowance as are admissible to the Grade-I Officers of the State Government as specified under the orders of the Government relating to the grant of TA/DA.
- (6) The Chairperson and the members shall be entitled to the medical benefits, leave and LTC facility as per their entitlement under the relevant rules/ instructions of the Government."
