1	11.09.2023	<p>The matter was called up for hearing. Ld. Mr. Adv Mohar Singh was present on behalf of Mr. Vivek Singh. and Dr Venkata VPRP were present. In this matter various documents were filed by the both the parties and very serious allegation were put against each other. Dr Venkata has submitted that there has been misuse of funds by the Chancellor Vivek Singh and he has submitted his resignation on 25.07.2023 and appointed Dr Venkata to look after the work of chancellor till the appointment of regular chancellor. He further submitted that four months salary of faculty and employees are pending and as per information from Finance officer of University statutory dues like provident fund worth Rs 3.79 Crores are pending and there is violation of EPF Act and to escape from PF contribution from Management side false salary of Rs 16,100 are shown per month to class IV employees whereas their salary is Rs 9000 per month, Dr Venkata further claimed that Mr Vivek Singh is not chancellor and he should not interfere in the functioning of the University. Management Arni University has allowed him as Executive Head of University as per UGC and police protection be provided to me against Mr Vivek Singh and he must surrender his license pistol with the police so that he will not threaten the staff to do illegal things. In support of this allegation Dr Venkata has submitted various documents along with his submission.</p> <p>Ld Adv Mr. Mohar Singh was present on behalf of Mr. Vivek Singh and submitted that a police complaint has been lodged against Dr Venkata for defaming the University and harming the reputation of applicant in the society and further submitted that Dr Venkata started putting allegation after he has been found ineligible vide letter dated 02.08.2023 and was discontinued from the service of Vice Chancellor with immediate effect on 10.08.2023 for the post of Vice Chancellor by the expert Committee constituted by this Commission. Moreover, dispute regarding supplementary trust deed dated 12.07.2023. is pending before the Hon'ble J. of Delhi and stay has been granted against it. The further submitted that payment of</p>	



further submitted that payment of RS 1,77,584 (Four Lakh Seventy-Seven Thousand and Five Hundred Eighty-Four) has been deposited in the account of Dr Venkata and his all dues are cleared.

The Commission after considering all the documents and submissions made by both the parties and several other similar complaints observes that in the Arni University so many criminal cases and all other civil litigation are going on and even allegations are levelled against Vivek Singh, CFO Robin and CEO Mr Chetan for doing fraud and for holding the salaries of employees for 2 months and 11 days and taking the help of bouncers and goons to frighten the staff. Even there is dispute regarding trust of the institution and it is not clear which is the genuine trust of the institution. It shows that in such disturbing and criminal environment the education level has been lower down and in the University situation has gone out of control, which has badly affected the functioning of the University and there is every likely hood that there may be distribution of fake degrees.

The Commission decided that so as to maintain the academic atmosphere there is urgent need to appoint administrator in the University, as there is no chancellor and even new Vice Chancellor is appointed without following any procedure and faculties are not being paid salaries regularly and so may criminal activities are going on in the University campus and number of FIR has been lodged against each other by the management of the University and Vice Chancellor Dr Venkata and there is also disputes regarding genuineness of trust of the University. Hence, this matter be sent to State Govt for appointment of Administrator in the University so as to avoid malpractices in the University and to avoid such criminal practices and to provide healthy atmosphere of education to students who are studying there. The matter be also sent to the state vigilance for enquiry regarding any distribution of fake degree by the University and preventing any other criminal activity in the campus of university.

Nothing survives in the matter and same may be disposed off.
