Subject: Admission criteria in Technical/ Non Technical/ Professional/ Non Professional courses for academic session 2015-16, in various Private Universities.

Sir,

In continuation to this department notification(s) of even no. dated 24/03/2014 & 20/05/2014 and letter dated 30/08/2014, on the subject cited above, I am to say that the matter regarding fixation of admission criteria in Technical/ Non Technical/ Professional/ Non Professional courses, was under consideration for some time past. After careful consideration it has been approved that admission to all courses for the academic session 2015-16 shall be as under;

- (i) wherever there is a National Common Entrance Tests all admissions would be on the basis of such an exam;

- (ii) in absence of National Common Entrance Tests the University concerned will be free to hold its own examination; and
- (iii) there will be no change in basic academic qualification already prescribed, i.e. the minimum qualification for admission in UG level professional/ technical course(s) be kept as ten plus two with 60% aggregate marks or 'B' grade/ equivalent from a recognized Board/ University, and shall be relaxable by 5% marks in case of SC/ ST candidates. The admissions shall be granted on merit basis determined by conducting entrance tests at the level of such University with cut off of 50% marks, (relaxation of 5% in case of SC/ ST candidates). The reservation of seats for SCs, STs, OBCs and Physical Handicapped shall be made as per policy of the State Government.

You are, therefore, directed to adhere to the instructions issued from time to time and take further necessary action in the matter accordingly under intimation to this department.
